Councilmember McGinn, seconded by Councilmember Bloyer, moved TO ADOPT RESOLUTION NO. 2020-102 RECEIVING THE AMENDED FEASIBILITY REPORT FOR THE HERITAGE FARMS STREET AND UTILITY IMPROVEMENTS AND CALLING HEARING ON IMPROVEMENT TO BE HELD ON JANUARY 19, 2021. Motion passed 5 – 0.

Councilmember McGinn, seconded by Councilmember Dorschner, moved TO ADOPT RESOLUTION NO. 2020-103 DECLARING COST TO BE ASSESSED AND CALLING HEARING ON PROPOSED ASSESSMENT FOR THE HERITAGE FARMS STREET AND UTILITY IMPROVEMENTS TO BE HELD ON JANUARY 19, 2021. Motion passed 5 – 0.

ITEM 27: Approve Feasibility Report & Call for Improvement Hearing - Tamarack Farm Estates Street Improvements

City Engineer Griffin presented the feasibility report for the proposed Tamarack Farm Estates project.

Mayor Pearson, seconded by Councilmember Dorschner, moved TO APPROVE RESOLUTION NO. 2020-104, RECEIVING THE FEASIBILITY REPORT AND CALLING A PUBLIC HEARING FOR THE TAMARACK FARM ESTATES STREET IMPROVEMENTS. Motion passed 5 – 0.

ITEM 29: 2021 LMCIT RENEWAL

Assistant Administrator Dickson reviewed the information regarding tort limits for the 2021 renewal.

Mayor Pearson, seconded by Councilmember McGinn, moved TO MAINTAIN THE CURRENT \$1,000 DEDUCTIBLE FOR THE CITY'S PROPERTY AND LIABILITY INSURANCE AND AUTHORIZE ELECTION TO NOT WAIVE THE STATUTORY TORT LIMITS. Motion passed 5 – 0.

ITEM 6: November 2020 Sheriff's Report

Councilmember Dorschner commented on the number of calls in the parks and the expense of patrolling parks with areas that are not readily visible.

Mayor Pearson, seconded by Councilmember Dorschner, moved TO ACCEPT THE NOVEMBER 2020 SHERIFF'S REPORT. Motion passed 5 – 0.
